I am receiving, from the School District of Lee County, ("District") the computer/device/item(s) identified below ("Equipment"). The Equipment is to be used solely by my student while enrolled with Lee Virtual School for educational purposes only. The Equipment is and will remain the property of the District. Any additional Equipment provided must be returned to the District in excellent working order (i.e., device, power supply, sleeve, etc.). I agree to return the Equipment by the end of the current school year (or as directed by the School District of Lee County). The Equipment includes, but is not limited to, any district-provided technology like that of a student Chromebook, an A/C Power Supply, and a sleeve/case; and may also include a hotspot package that contains the device, a charger, and a specially prepared box with district labeling.

I understand that the Equipment, like textbooks and other academic resources, is instructional material, and I am responsible to ensure that the Equipment is properly handled. I understand that I am legally responsible for the following:

- 1. the full replacement cost if Equipment is lost, stolen, damaged or seized while in my possession;
- 2. the repair costs if Equipment is mistreated, uncared for, vandalized, or damaged while in my possession;
- 3. if the Equipment is stolen, while in my care, I am responsible to report the item missing or stolen to and must provide Lee Virtual School with an authorized police report with device serial number clearly marked on the report;
- 4. monitoring and controlling my student's use of the Equipment including Internet access. While the District makes every effort to limit access to inappropriate content through Internet filtering systems, inappropriate use is a violation of the Code of Conduct for Students and *School Board Policy 2.20*.

The District reserves the right to monitor or access the contents of its computers if it suspects or is advised of possible breaches of security, harassment, or other violations of policies, rules, regulations, directives, law, or evidence exists which demonstrates to the school or District that its computers may contain information, data, or other intellectual property that belongs to another person. Students have no expectation of privacy of content stored on or accessed through District Equipment. Students are reminded to only use the Equipment for academic purposes and not to engage in non-academic activities.

Any software and instructional content contained on the Equipment is licensed to the District. Any copying, modification, merging or distribution of the software is prohibited. The student is responsible for complying with any and all hardware, software and service provider licensing agreements, terms of use and applicable state and federal copyright and other intellectual property protections. Violation of any such licenses, terms or laws shall constitute a violation of *School Board Policy* 2.20. Only software approved by the District may be installed on the Equipment. Students must not intentionally modify system configuration files or otherwise interfere with the functioning of the Equipment.
